BUSINESS LAW BSMG 6203

Course Outline

Description: Understand various legal relationships in business. This course introduces Canadian Business Law including: forms of business organization, contracts, negligence, leasing, financing, labour and employment, e-commerce, intellectual property, international business transactions, conflict resolution and negotiation. Through in class practice, learn how to identify and analyze legal issues as they relate to your business.

Course Goals: The goal of this course is to enable students to identify, analyze and make decisions pertaining to legal issues in business.

Course Objectives:

At the completion of this course, the student will be able to:

- Develop an understanding of Canadian business law and general legal principles as they apply to business
- Identify and analyze legal issues including forms of business organization, contracts, negligence, leasing, financing, labour and employment, e-commerce, intellectual property, international business transactions, conflict resolution and negotiation
- Understand various legal relationships found in the business environment
- Understand, analyze and interpret different types of business contracts

Evaluation:

You will be evaluated on the basis of two midterm exams (25% each), a final exam (35%) and participation mark (15%).

Exams will be closed-book and may consist of both multiple-choice and short answer questions. No electronic devices or paper aids (i.e. dictionaries) will be allowed at the midterm tests or final exam.
