Description: Learn the best management practices for developing and executing an effective fund development program and fundraising strategy. Building a comprehensive development program is the key to creating a sustainable nonprofit organization. Various fund development techniques will be introduced in this course, with the help of key speakers from the sector. Topics covered include: planned giving, major giving, fundraising theory, ethics, and direct response programs.

Course Goals: To create an understanding and primary knowledge of key fundraising strategies and best practices and techniques for a superior fund develop program.
