## Mediation Skills and Processes ADRN6204

#### **Course Outline**

**Description**: You will explore the role of the neutral mediator and ethical standards that apply to mediation. As a mediator, you are a negotiation facilitator who is disinterested in the outcome of the negotiation. You will have opportunities to practice structuring and facilitating mediation sessions, as well as the communications skills and interventions that you will require when mediating disputes. The ADR Institute of Ontario (ADRIO) has approved this course, in combination with Collaborative Conflict Resolution, as a prerequisite for mediator membership. You will be eligible to receive a certificate from the ADRIO acknowledging your completion of the approved program.

### Pre-Requisite: Collaborative Conflict Resolution

**Course Goals:** To introduce participants to the practice of mediation and provide them with a step by step process as well as communication tools to assist disputing parties reach a resolution. Participants will practice the process and the skills in mediation role plays in a small group with a coach. A review of the Collaborative Conflict Resolution course manual before the beginning of the course is recommended.

**Course Objectives:** At the completion of this course, students will be able to:

- Understand the purpose and limitations of mediation
- Appreciate the mediator's role including ethical imperatives
- Learn how to structure and conduct a mediation, including screening and orienting the parties
- Learn the skills and approaches that assist mediators to facilitate problem-solving and achieving settlement
- Implement the interest-based approach introduced in Collaborative Conflict Resolution
- Develop empathy by playing the roles of disputants
- Practice mediating (including use of the mediation model, problem-solving and communication skills) with coaching from the instructor and knowledgeable coaches

**Texts:** Course manual is provided at the start of the course
